2		How Can My Client Stories Inform Massage For Cancer Practice, Education, And Research?  Massage clinicians who work with oncology patients have a trove of stories that could inform massage practice, education and research.  Case reports are excellent vehicles to convey such stories but the thought of putting together and publishing a case report can be intimidating. This seminar will provide 1) examples of how treatment notes can be used to retrospectively report meaningful and interesting examples from practice, 2) a roadmap to case report development and publication, and 3) an opportunity for participants to tell their interesting practice stories and develop an individualized case report outline of their most interesting practice story. 3		Pain Science: Key Concepts for Evidence-Informed Practice  People may have pain for many different reasons, and current pain science advocates a whole-person approach to assessment and treatment. Learn key concepts in pain science and how to apply them in practice, regardless of the setting in which you work. This includes practice of hands-on applications and discussion of dermoneuromodulation in all forms of manual therapy. Pain science is a multidisciplinary field of study, and the treatment of pain raises some interdisciplinary and ethical issues that massage therapists increasingly need to understand. This workshop covers concepts and methods appropriate for all forms of manual therapists, and emphasizes language and techniques used by massage therapists, physical therapists, occupational therapists, chiropractors, and other health care professionals. As time has passed, restrictions have been lifted, but many of us still are unclear about how to proceed or even if to proceed doing the work that we love. Is it safe for our clients? Is it safe for us? What risks are we prepared to take? What is the right answer?  The Healing Summit COVID-19 panel has been convened to explore these issues. Each panelist will share how they changed their work and the reasons behind those choices. They will also answer questions from the group, provide an understanding of where to find and how to follow quality data/research, and discuss the need for ethics and evidence-led guidelines for massage therapists and our profession as a whole. 1		Oncopharmacology (Introduction level session) It is safe to predict that most people living with cancer use medications. It is also safe to say that many massage therapists have little information on how those medications work, and how massage therapy might affect their function. This introductory pharmacology class addresses basic principles of drug mechanisms, possible side effects and adverse reactions, and how massage can be adjusted to meet those concerns. 2		Creating and Executing a Marketing Plan Where do I start? How much should I budget? Should I have a Grand Opening or throw my energy into AdWords? Most of us run flailing into various marketing tactics, without creating a cohesive plan of action to work from. The results: mediocre and not particularly helpful.  We'll walk through the questions to ask, the ideas to consider, and you'll leave with a drafted plan to execute a marketing strategy that will get more clients on your table.	Allissa Haines
3		Under Pressure? Working Deeply Without Deep Pressure Clients frequently request deep tissue massage, and many oncology clients expect their "usual" deep massage, through cancer treatment and beyond. It can be a challenge to meet client hopes and expectations, while providing a safe, effective, and satisfying massage session. In this session, we will practice hands-on techniques that can make a gentle oncology session feel deeper. We will explore the language we use to describe pressure. We will provide language scripts for those difficult moments with clients who want deeper work than we can provide. We will practice them to prepare for clients who challenge our gentle approach. 1		Untangling the Lymphatic Web: Lymphatic research continues to provide a valuable insight on the function and workings of the lymphatic system. Newly developed methods of diagnostic imaging have enabled us to clearly understand how lymph moves through the vast web of lymphatic vessels, allowing therapists trained in Manual Lymphatic Drainage to provide treatments that effectively promote the movement of lymph.
